Our Round Log production now exceeds 450,000m³ annually and therefore as one of Ireland's leading timber processors we are seeking to purchase Clearfalls, Windblow Standing and Roadside and Thinnings Roadside, **Nationwide**. We will purchase both Roadside and Standing material. Our professional and experienced forestry team can visit your site, give a detailed quotation or answer any questions you may have. In all our forestry harvesting operations we design a harvesting plan within the terms of your felling licence and our aim is to maximise the income generated from your plantation.



Necessary steps if you are a forest owner wishing to sell.....

- Contact a member of our Forestry Team who will take all necessary details.
- We will arrange a visit to your plantation and give you a detailed quotation.
- We will advise you as to what steps to take in order to obtain a Felling Licence (if required).
- Draw up a purchase contract.
- We can help with the planning of a new forest road.
- We will contract Harvesters (if required) and Licenced Hauliers.

Post Purchase

- All timber is tracked with a timber docket accounting system.
- The total tonnage harvested will be calibrated at our certified weigh bridge.
- ECC will provide a regular schedule of collections upon request.

Health and Safety

ECC takes Health and Safety very seriously in all its timber Harvesting and Haulage operations. Firstly we do this by only engaging trained and competent contractors with the right machinery designed for the job. Our Health and Safety system is constantly evolving to minimise risk in these operations in order to ensure that work is carried out safely.

Timber Harvesting

We have several harvesting contractors operating a range of purpose-built harvesters and forwarders to deliver a high quality system for the felling of Clearfalls and Windblow.

Timber Haulage

Our haulage contractor structure can deliver in excess of 450,000m³ of round log per annum. They strive to use new technology such as Central Tyre Inflation control systems to minimise damage to forest roads. Our haulage contractors operate to the standards set out by the Road Safety Authority of Ireland.

Environment

All our harvesting contractors have successfully completed an Environmental Impact Assessment (EIA) Course which covers such areas as Water quality guidelines and Archaeology guidelines.

Security

The security of our suppliers stock and property is of utmost importance to our company. To ensure time security is maintained to the highest level, ECC implement the following measures:

- CCTV on all private sites.
- Timber Removal Permit system which tracks each load individually.
- Site supervision on a regular basis by ECC personnel.
- Only approved licenced hauliers contracted by ECC.
- Regular progress reports to the supplier.
